REACH Update

Martin Marietta Magnesia Specialties LLC through our "Only Representative", NOTOX of the Netherlands, has received confirmation that the pre-registration of our products was successfully submitted.

We have pre-registered magnesium oxide, magnesium hydroxide and magnesium stearate. The pre-registration covers all product grades of magnesium oxide and hydroxide made by Martin Marietta at our Manistee, Michigan and Woodville, Ohio facilities.

We expect to register our products for downstream uses that include technical, industrial, agricultural, chemical processing and rubber/plastic compounding applications. The exact terminology will be determined at a later date.

Our coated products, MagShield S NB10 and MagShield UF NB10, consist of magnesium hydroxide coated with magnesium stearate. We therefore pre-registered magnesium stearate as a separate component.
